Zone 4 Landfill Construction Projects and Organic Waste Recycling Facility

Background: The Prima Deshecha Landfill (landfill), located at 32250 Avenida La Pata, San Juan Capistrano, is a solid waste landfill owned by the County of Orange and operated by OC Waste & Recycling (OCWR). In November 2001, the Orange County Board of Supervisors approved Final Environmental Impact Report (EIR) 575 for the development of the landfill through build-out. The two approved landfill development areas are designated Zone 1 and Zone 4. In compliance with the California Environmental Quality Act (CEQA), OCWR will be preparing a Supplemental EIR (SEIR) to analyze construction projects in the Zone 4 landfilling area that were not previously analyzed in Final EIR 575. In addition, OCWR will analyze the potential impacts associated with both construction and operation of a fully enclosed organic waste recycling facility, thereby helping the County and incorporated cities meet state mandated organic waste diversions recycling goals.

Public Information Meeting: OCWR invites community members to attend a virtual information meeting to learn more about the SEIR being prepared for the Prima Deshecha Landfill and to provide comments on the project. Staff will be available to provide information and answer questions regarding the SEIR process and the project components that will be analyzed in the SEIR.
