Agenda Item 2 – OC Waste & Recycling's FYE 22/23 Financial Report Trang Doan, Financial Services Section Manager

This report presents the financial status of OC Waste & Recycling at Fiscal Year-end 2022/23 and the related financial information for tonnage, expenditures, revenues, reserves and cash balances.

System Tonnage

Total system tonnage received in FY 22/23 was 5,071,056 tons, consisting of 3,530,462 in-county tonnage and 1,540,594 importation tonnage. In-county tonnage has risen by 1.9% from last fiscal year. Importation tonnage has decreased by 3%.

By landfill site, FY 22/23 tonnage was as follows:

Olinda Alpha Landfill

In-county tonnage1,366,870 (38.7%) of total in-county tonnageImportation tonnage679,565 (44.1%) of total importation tonnage

Frank R. Bowerman Landfill

In-county tonnage	1,590,824 (45.1%) of total in-county tonnage
Importation tonnage	622,634 (40.4%) of total importation tonnage

Prima Deshecha Landfill

In-county tonnage	572,768 (16.2%) of total in-county tonnage
Importation tonnage	238,395 (15.5%) of total importation tonnage

Revenues

For FY 22/23, revenue recorded in OC Waste & Recycling's Enterprise / Operating Fund (Fund 299) was \$195,781,154 or 113.9% of the modified revenue budget of \$171,893,078. Primary sources of revenue received in FY 22/23 included:

- \$136,647,411 In-county Disposal Revenue (69.9% of total revenue received)
- \$30,156,016 Operating Reimbursement from Importation (15.4%)
- \$8,304,828 AB 939 Surcharge (4.2%)
- \$8,086,605 Interest Income (4.1%)
- \$5,310,143 Soil Charge, Insurance Proceed & Other Revenue (2.7%)
- \$4,576,152 Leases & Royalties (2.3%)
- \$2,700,000 SB 1383 Grant Revenue Accrual (1.4%)

For FY 22/23, revenue recorded in OC Waste & Recycling's Capital Project Fund (Fund 273) was \$15,329,286 or 19.2% of the modified revenue budget of \$79,847,098. Revenue received includes interest earnings of \$1,934,220, and total transfers-in of \$13,393,627 including funding from Operating Fund 299 and recording of construction in progress. Due to the deferral of several major capital projects, actual transfer-in from Fund 299 was only a small portion of the modified budget.

For FY 22/23, revenue recorded in OC Waste & Recycling's Importation Net Revenue Sharing Fund (Fund 295) was \$49,568,634 or 97.6% of the modified revenue budget of \$50,800,000. Revenue received includes total interest income of \$678,176 and importation tonnage revenue of \$48,890,458.

Expenditures

FY 22/23 expenditures and encumbrances recorded in OC Waste & Recycling's Enterprise/Operating (Fund 299) totaled \$148,292,611 or 51.7% of the modified expense budget of \$286,693,949. FY 22/23 expenditures and encumbrances recorded in OC Waste & Recycling's Capital Project Fund (Fund 273) was \$527,478. This is the combination of accounting entries for capitalization of completed capital projects, depreciation expense and encumbrance balance at fiscal year-end. Actual spending on capital projects during the year was \$39,138,922 or 32.2% of its modified budget of \$122,356,812.

For FY 22/23, OC Waste & Recycling's major categories of expenditures including postclosure maintenance (PCM) were:

- \$68,739,264 Services & Supplies (35.3%)
- \$39,138,922 Capital Project (20.1%)
- \$34,501,531 Salaries & Employee Benefits (17.7%)
- \$14,934,131 Importation Net Revenue Sharing (7.7%)
- \$14,343,855 Taxes, Fees, Assessments (7.4%)
- \$11,820,427 Equipment (6.1%)
- \$10,755,446 Postclosure Maintenance (5.5%)
- \$650,482 AB 939 Surcharge Program Spending (0.3%)

Cash Balance and Reserves

As of June 30, 2023, the OC Waste & Recycling's Enterprise/Operating Fund 299 had a cash balance of \$323,306,081.

As of June 30, 2023, the OC Waste & Recycling's Enterprise/Operating Fund 299 had an available reserves balance of \$50,831,274.
